ALDERMAN FINN MOVED TO ADD TO THE AGENDA 2.15 CROSSWALK AT HUNTINGTON STREET AND ROARING BROOK. SECONDED BY ALDERMAN LANZI. ALL IN FAVOR. MOTION CARRIED 3-0.

ALDERMAN FINN MOVED TO START WITH OLD BUSINESS 3.1 UNREGISTERED VEHICLE ORDINANCE FOLLOWED BY NEW BUSINESS

2.7 HUNTINGTON STREET SIGN IMPROVEMENTS. SECONDED BY ALDERMAN LANZI. ALL IN FAVOR. MOTION CARRIED 3-0.

3.1 UNREGISTERED VEHICLE ORDINANCE

ALDERMAN FINN MOVED TO RECOMMEND TO THE FULL BOARD FOR PUBLIC HEARING ON ORDINANCES OF JUNE 23, 2005 THE REVISED ORDINANCE #548 FOR ABANDONED OR UNREGISTERED MOTOR VEHICLES. SECONDED BY ALDERMAN LANZI. ALL IN FAVOR. MOTION CARRIED 3-0.

Alderman Papa discusses that we added section #8 to help the Chief and Planning & Zoning to go after abandoned cars on private property.

ZEO Tom Dingle states it is an amendment to the original ordinance to help them go on to private property to remove vehicles. Going to civil courts takes six, to nine months and also there is appeal time. This expedites the situation and shouldn't be abused and it is also important that the Police Department is on board. It will give the property owner plenty of time to cooperate. Also a notice goes into the newspaper.

Alderman Papa states the Planning & Zoning office and Police Department worked together with this.

The section that is amended is as follows:

Section 8:

- A. Any motor vehicle located on private property that is abandoned or inoperable or unregistered and remains unmoved for a period exceeding thirty (30) days after the Zoning**

- Enforcement Officer has (1) provided notice to the property owners on which such motor vehicle remains, requesting removal of such motor vehicle and (2) said notice was published in a newspaper having a substantial circulation in such municipality; may be removed by the City of Shelton.
- B. The Zoning Enforcement Officer shall be responsible for notifying such property owner, publication of the general notice, and for removal and disposition of such motor vehicle by an approved City of Shelton towing company as authorized by the Police Department.
 - C. The property owner shall be responsible for the cost of the removal of any motor vehicle and shall be fined not more than One Hundred Dollars (\$100.00) for each day (each day being a separate offense) that the vehicle remains on the property after the thirty (30) day notice expires.
 - D. A property owner that moves the motor vehicle on the property does not exempt said vehicle from this ordinance.
 - E. The Shelton Police Department may issue the City ordinance violation prior to the removal of said vehicle.

2.7 HUNTINGTON STREET SIGN IMPROVEMENTS

ALDERMAN FINN MOVED TO FORWARD TO THE DIRECTOR OF HIGHWAYS AND BRIDGES PER THE RECOMMENDATION OF THE CHIEF OF POLICE TO APPROVE THE HUNTINGTON STREET SIGNAGE IMPROVEMENTS AS DETAILED IN THE ATTACHED MEMO. SECONDED BY ALDERMAN LANZI. ALL IN FAVOR. MOTION CARRIED 3-0.

Memo from Chief Voccola to Alderman Papa dated May 24, 2005:

The following improvements to the signage on Huntington Street have been ordered:

- ◆ Near Commerce drive, the existing 30 MPH will be replaced with a larger (24 x 30) size
- ◆ Near Trap Falls Road Extension, the “side road” signs will be replaced by a larger (30 x 30) size.
- ◆ Near Trap Falls Road Extension, a 30 x 30 “Winding Road” sign will be installed.
- ◆ Huntington Street, north of Trap Falls Road, replace existing “School Bus Stop Ahead” with new 30 x 30 sign.
- ◆ Huntington Street, south of Trap Falls Road, install new (24 x 30) “30 MPH Limit” sign
- ◆ Huntington Street southbound near #504, install (3) new chevron alignment signs (18 x 24)
- ◆ Huntington Street near #536 southbound, replace existing “30 MPH Speed Limit” sign with larger (24 x 30)
- ◆ Huntington Street near Isinglass Road cut back brush near the Route 8 sign.
- ◆ Huntington Street between Isinglass and Bridgeport Avenue, install new (36 x 36) advance signal sign southbound.
- ◆ Huntington Street northbound near #586, install new (24 x 30) “30 MPH Speed Limit” sign.
- ◆ Huntington Street, south of #504, install (3) new chevron (18 x 24)
- ◆ Huntington Street northbound near #500, install new (24 x 30) “30 MPH Speed Limit” sign.
- ◆ Huntington street south of Trap Falls Road, install new (30 x 30) side road sign.
- ◆ Huntington Street north of Trap Falls Road, replace existing “30 MPH Speed Limit” sign with larger (24 x 30)
- ◆ All existing signs will either be straightened or replaced if faded, as needed.
- ◆ All areas with brush will be trimmed as needed.
- ◆ Weather permitting; the lines on the street will be repainted, including the white fog lines.

We will continue to monitor the area with use of radar, laser and our educational speed monitoring radar trailer.

The Chief states that the Mayor has a proposal for an Engineer to come in and look at this situation. It will happen in the near future. The Chief also points out that Commerce Drive at the end of June will be renovated and there will be an increase of traffic on Huntington Street and Bridgeport Avenue during this time. The Police are out there but Huntington Street is not the only street being monitored in the City.

Alderman Lanzi states also on River Road, there is much speeding.

Alderman Finn makes an observation of the speeding on this road.

Mrs. Daniels of 502 Huntington Street presents the Board with pictures she has taken along this strip of road. She states her neighbor’s car was hit by a 17 year old boy and

totaled car. This happened on Trap Falls and Huntington Street. She feels there is an element on this road that should be addressed. The Chief and Committee ask Mrs. Daniels about what she means as an element in the road. She states people drive over the center line coming from the curve.

She discussed the pictures with the Chief and Committee and they are on file in the Office of the Board of Aldermen. She has put up reflectors on the street. She feels when they come along the road it is a curve and they are crossing the center line.

Chief Voccola states he does not take this lightly. He was there that day the boy was killed. Mrs. Daniels thanks the Chief for meeting with her.

2.6 REQUEST FOR TRAFFIC LIGHT – BRIDGEPORT AVE.

Chief Voccola states this is a State Road and a Traffic Light is scheduled to be put up at this location.

Note to clerk: Please send a letter to Mr. Viglione that this is being addressed and a street light will be going up in the neighborhood of that location.

2.18 182 WALNUT TREE HILL ROAD

The feasibility of the installation of flashing, times warning lights to be attached to existing signs will be forwarded to the Engineering Department for review.

The Chief states that in front of Sunnyside School with the Deli across the street the trucks block the driveways and they can't get in or out. He has a police officer there in the morning and has asked the State to post it "no parking".
