**1. MINUTES FOR APPROVAL**

**1.1 STREET COMMITTEE MEETING – October 15, 2019**

Alderman McPherson MOVED to waive the reading and approve the Street Committee Meeting Minutes of September 3, 2019. SECONDED by Alderman Kudej.

## 2. NEW BUSINESS

### 2.1 SIDEWALK REIMBURSEMENT- 42 HIGHLAND AVENUE

Alderman McPherson made a motion to MOVE, per the recommendation of the City Engineer, to recommend to the full board to approve the sidewalk reimbursement of \$5960. To Christopher & Andrea Masso, 42 Highland Avenue, Shelton, CT 06484 per Ordinance #877 (Section 14-9 of the code of Ordinances) with funding to come from the Sidewalk Reimbursement account #001-3600-713.80-43. SECONDED by Alderman Kudej. A voice vote was taken and the motion passed unanimously.

### 2.2 MONROE STREET DRAINAGE

Alderman McPherson: This area is a nightmare. It's a ditch, the pipe runs underneath someone's driveway, you can see it. I talked with the resident of #54 up there and they are getting run off onto their property, on the other side of the road. This is probably a big undertaking to do but it's necessary. It's a high priority.

Brian Roach: I know. It's been like that for a while there, I think that's how they designed the road to handle the water. There was a driveway lip but that's probably not enough. I will talk to Rimas about this.

### 2.3 STORM DRAIN ON CORAM AVENUE – ACROSS FROM ELM STREET

Alderman McPherson: I believe its #415, about 20 feet up, the storm drain there is full. It looks chock full of sand. I think we need to have the State clear it out and I'll also talk to Representative Perillo to see if he can have the State Dot get out there.

Brian Roach: Yes, the State needs to clear it out.

### 2.4 PERRY HILL ROAD OVERGROWN BRUSH

Alderman McPherson: The brush issue there is when you're coming up Perry Hill and just where Perry, Wooster & Meadow meet, there's a big retainer wall area that needs trimming. Can we get the brush cut back?

Brian Roach: Yes, I'll get the mower out there.

### 2.5 MEADOW STREET OVERGROWN BRUSH NEAR SIDEWALK HEADING TOWARDS SHELTON AVENUE ON RIGHT SIDE

Alderman McPherson: I believe this area is alongside the high school side, near the maintenance area. I don't think that it's something for us to handle and probably something that Parks & Rec can handle. I'll give a call to have them handle this brush and maybe the other overgrown brush as well.

2.6 15 CRIBBINS AVENUE- CURBING

Alderman McPherson: I took a photo after a call from the resident. We have done an area but have to come up further.

Brian Roach: Yes, I have taken a look at this. I drove out there last week. We are going to build up the lip. We will be getting to it.

**3. OLD BUSINESS- FOLLOW UP**

3.1 KNEEN STREET/FOREST AVENUE INTERSECTION

Alderman McPherson: Have you gotten to this? Has it been done?

Brian Roach: Yes, we cut some stuff back but haven't gotten to the curbing yet.

Alderman McPherson: I'm keeping this on as old business so it stays on the burner.

3.3 44 CORAM AVENUE CURBING

Alderman McPherson: I made an error on this, the correct address is #144 Coram. On the corner of Myrtle and Coram. This water issue is similar there to where we need curbing.

Brian Roach: Oh, okay. Yes. We plan on getting it done.

3.4 GROVE STREET UPDATE

Alderman McPherson: This issue is a similar situation to item 2.2 and will need to get some patching done until we pave.

Brian Roach: Yes. We have been there and cleaning basins.
