◆ **CALL OF THE MEETING**

Alderman McPherson called the meeting to order at approximately 7:00 pm in room 104 at Shelton City Hall. All in attendance recited the pledge of allegiance.

No one spoke at the public portion of the meeting.

◆ **AGENDA ITEMS**

1. MINUTES FOR APPROVAL
 - 1.1 **REGULAR MEETING – SEPTEMBER 1, 2009**

Alderman Kudej moved to waive the reading of and approve the meeting minutes of the regular meeting of September 1, 2009; seconded by Alderman Farrell. A voice vote was taken and the motion passed 3-0.

2. NEW BUSINESS
 - 2.1 **NEW STREET COMMITTEE POLICY**

A motion was made that all requests for items on the Street Committee Agenda be in writing with name, address, phone number and backup material addressed to the Chairman and copied to the Board of Alderman Clerk; seconded by Alderman Farrell. A voice vote was taken and the motion passed 3-0.

2.2 SIDEWALK REIMBURSEMENT REQUEST – 161 CORAM AVENUE

Alderman Kudej moved to recommend to the full board, per the recommendation of the City Engineer, to approve the sidewalk reimbursement of \$240.00 to Theresa Waldron-Yancoskie of 297 Long Hill Ave., per Ordinance no. 465 with

funding to come from the Engineering acct #001-3600-713.80-43; seconded by Alderman Farrell. A voice vote was taken and the motion passed 3-0.

2.3 126 MYRTLE STREET

Alderman Kudej asked Mr. Mooney to review the road in front of 126 Myrtle Street for patch work to the road. Mr. Mooney reported that it would be reviewed and he would report back.

2.4 WEST STREET

2.5 GEISSLER DRIVE

The Aldermen discussed and agreed that both West Street and Geissler Drive need to be repaved. Mr. Mooney will report back to the committee.

2.6 BLACK HILLS ROAD

Discussion. Alderman McPherson reported that there are many issues with this road, i.e.; looking for a guardrail, erosion of roadside, dead tree. Mr. Mooney will review and report back to the committee. He also stated that the plow trucks needed room to turn around at the dead-end, the dead tree may be on private property and that the Police Department should be notified of any signage that may be needed regarding Dead End etc.

2.7 MONTGOMERY STREET

Alderman Kudej reported that there were severe curb washouts and potholes along Montgomery Street. Mr. Mooney stated that he will review and report back to the committee.

2.8 Robert Street

Mr. Mooney reported that part of this has been addressed and that H&B has patched all that can be patched. He reported that the culvert is in poor shape and will need work by an outside company. Mr. Mooney addressed the report of brush along the side of the road. This was a private tree which had fallen across the road. The City cleared the road as required but it is the homeowners responsibility to have the brush removed.

3. OLD BUSINESS

3.1 LANE STREET – UPDATE FROM HIGHWAYS & BRIDGES

The committee discussed this and agreed that the brook needs to be cleaned up from the Huntington Center Hardware Store to Buddington Road or the flooding will continue in the future.

A motion was made to forward this to the City Engineer for review and recommendation.

3.2 LONGFELLOW ROAD, DICKENSON DRIVE, WEBSTER DRIVE, MARTINKA DRIVE, LENORE DRIVE , SCHOOL STREET – UPDATE FROM HIGHWAYS & BRIDGES

Mr. Mooney reported that all of these roads need attention – more than just an overlay. Discussions have been taking place regarding the repair of these roads with the Director of Public Works.

ADJOURNMENT

Alderman Farrell moved to adjourn the Street Committee meeting at 7:25 pm.; seconded by Alderman Kudej. A voice vote was taken and the motion passed 3-0.
