# Call to Order/Pledge of Allegiance

Alderman Anglace called the regular Board of Aldermen meeting to order at 5:30 p.m. in the auditorium at Shelton City Hall. All those present stood and pledged allegiance to the Flag of the United States of America.

#### **PUBLIC PORTION**

Alderman Anglace asked if anyone wished to address the board.

I see our Mayor is absent as I was hoping to address him pertaining to, of course, the road at Riverview Park which is still unpaved. I have been asking the town to do that for years now. I submitted petitions of people who agree and would like it paved as well, but instead you paved the parking lot in front of the Post Office, not that it needed it.

If you have been watching the news you have seen that many mayors around the country have been signing executive orders, supposedly to ban ICE operations in their towns. It is rather ludicrous since

they can't enforce it. In fact, I spoke to Mayor Lauretti last month about signing on to the Immigration and Nationality Act of 1996, specifically Section 287G which will allow our police department to assist ICE in removal of the illegal aliens in towns. He is reluctant to do this, for some reason he is afraid Hartford might penalize Shelton. Unfortunately, they cannot take action against Shelton if he chooses to sign on due to the supremacy clause in the constitution which federal law trumps state law. There are a couple of good reasons why he should sign on for this. As you know, the big beautiful bill that was signed by President Trump on the 4<sup>th</sup> of July gave the Department of Homeland Security a \$75 billion budget and DHS has now, last month anyway, said that they will pay the salaries of all the police departments that sign on. There are two good reasons to do that. One, it will be assisting ICE in enforcing immigration laws, keeping Shelton safe. It would be the town of law and order unlike any democratic rivals who I am sure will object. Part two would be the enormous financial incentive. I don't know what you spend on the police department annually but it would be a considerable savings. I would encourage you all to talk to Mayor Lauretti to do so soon. Thank you.

Alderman Anglace asked if there was anyone else wishing to address the Board. Hearing none, the Public Portion is closed.

#### PRESENTATION OF THE PROCLAMATION

Alderman McPherson asked for Joe Ciccone as well as Alderman Simonetti to come forward to present Joe Ciccone the proclamation. Alderman McKinnon was on Zoom and was not able to be present in person for the presentation but will be provided with a copy of the proclamation.

Alderman McPherson: I have invited Joe Ciccone here to present him with a copy of the official proclamation declaring the official city flag which was formally unveiled on Shelton Day and displayed at the Veterans Park. We also have one of the flags now on the flagpole in front of City Hall. I wanted to present Joe with a copy of the official proclamation. Alderman Simonetti has one and also Alderman

McKinnon will have one as do I. Joe, in recognition of your work where you approached the City and the Mayor who then got myself, Anthony and Porter involved with this undertaking, the amount of work, research and going through all the companies that you needed to do as well as the Historical Society, Libraries, Schools and the amount of work, we want to present you with an official copy of the actual official proclamation for you, which is now enshrined in the official records of the City of Shelton. Thank you very much for your work. Phase two which will be the interior flags.





Alderman Anglace: On Shelton Day, the proclamation was read. It was extremely comprehensive and this project is an example of what can happen, how one person can influence the government and how change can be affected. In this case it was done right. It involved the people of Shelton making the final decision. Everything was well thought out and all the actions were extremely comprehensive. Everyone had a say in the matter and it was truly a community decision in adopting our own flag and which flag to adopt. Hopefully, this will get promulgated throughout the community and the schools and our children will learn a little more about our history from the flag and from the process that took place. Most important to me was the fact that the decision was of the people, for the people and by the people. I certainly wish to thank the Board of Aldermen Committee, Porter McKinnon, Anthony Simonetti as well as Eric McPherson who championed this and saw it through. It took time. Time always frustrates us as when we get an idea and we want it done yesterday and we want it done our way. This was not done yesterday and it was done with the full involvement of the entire community which is the way it should be as we represent the community. Thank you everyone involved with the flag. It is truly a good achievement.

## 5.3.1 76 HOWE AVENUE SIDEWALK REIMBURSEMENT

Alderman McPherson MOVED, per the recommendation of the Street Committee, to approve a reimbursement of \$720.00 made payable to Glenn Ganz, 18 Bridge End Farm Lane, Sandy Hook, CT 06482 for the repair of a sidewalk at 76 Howe Avenue, per Ordinance #877 (Section 14-9) with funding to come from the Sidewalk Reimbursement Account #001-3600-713.80-43.

## **REPORT OF THE PRESIDENT**

Alderman Anglace: I would like to ask Corporation Counsel if he would summarize the court case of Rodeo Cannabis Company v Planning & Zoning Commission for the City of Shelton Docket No: CV-24-6058223-S. They were denied by Planning & Zoning and they took us to court.

Attorney Teodosio: We won. You had passed a resolution saying that you did not want cannabis in the City of Shelton. However, there had been an application to Planning & Zoning which antedated your action, so Planning & Zoning had to entertain the petition, but they denied it. The court said that their denial, because they were utilizing their legislative capacity as a Board, was valid and sided with them saying that because it was not unreasonable, arbitrary or capricious, then it was a valid decision. The appeal was denied which is why I say you won.

Alderman Anglace: Will they appeal that court decision?

Attorney Teodosio: I have information that they are appealing, but I have not seen anything yet.

The Citizens Advisory Board has sent us a copy of a letter that they sent regarding correspondence they had with Congresswoman Rosa DeLauro's office alerting her to their recommendations on the Two-Mile Island parcel. I think it is significant that they followed up again to let Congresswoman DeLauro know that there is still a lot of interest in that project. They want to let her know that if she needs them to be involved in developing any data or information that they will help her and participate. They don't want it to just sit on the shelf some place.

Dear Congresswoman Rosa DeLauro

On behalf of the Citizens Advisory Board (CAB) of Shelton, Connecticut, we would like to request a meeting with you regarding a land acquisition proposal that we believe holds great promise for the City of Shelton, our surrounding communities, and all residents of the State of Connecticut and our country.

We were appointed to our positions on the CAB by Mayor Mark Lauretti, who fully supports our mission and this initiative. We have identified an approximately 25-acre parcel of land in Shelton on the Housatonic River-known as Two-Mile Island - currently owned by the Beard/Tate families that we understand may be available for sale. We believe this property presents a valuable opportunity to become part of the Stewart B. McKinney National Wildlife Refuge; thereby, protecting critical riverfront land along the Housatonic River and contributing to regional conservation efforts. If created, it would be the only estuary unit in the McKinney Refuge system, makine it unions. Refuge system, making it unique.

We have already met with the family's attorney to express our interest in preserving this land for public benefit. The mayor has indicated a strong desire to collaborate with your office and the CAB on this matter, and he has asked that we help facilitate a meeting to discuss this proposal

We are asking if it would be possible to have an in-person meeting at your earliest convenience to bring you up to date on the proposal's progress and to explore potential steps toward

acquisition, including coordination with appropriate federal agencies. We are confident that with your guidance and support, we can develop a viable path forward.

**8.1 OCTOBER STATUTORY REFUNDS**

Alderman McPherson MOVED to add the purchase and installation of a Volta Inclusive Spinner at Riverview Park and East Village Park playgrounds to the Capital Improvement Plan with funding in an amount \$25,516 to come from LoCIP.

Alderman Anglace: As I understand it these will be administrative vehicles and do not have all the bells and whistles and are for different use. The vehicles include a used 2022 Honda Pilot SUV for \$35,995 and a used 2022 Honda Pilot SUV for \$31,594.

Alderman Simonetti: Will they have to be outfitted with the interior equipment, radios, etc.?

Alderman Anglace: I would imagine they would have to be outfitted with everything except the emergency equipment.

#### Discussion:
